

# BISHAN-TOA PAYOH GRC AND MARYMOUNT SMC COMMUNITY SCHOLARSHIP

IMPORTANT: Please read through the below Terms and Conditions before proceeding with the completion of the application. Please retain pages 1 and 2 for information.

#### 1) What is the Bishan-Toa Payoh GRC and Marymount SMC Community Scholarship?

The scholarships are awarded by the Bishan-Toa Payoh GRC and Marymount SMC to provide financial assistance to Singaporean children of Bishan-Toa Payoh and Marymount residents who are pursuing tertiary studies in local universities, polytechnics and the Institute of Technical Education (ITE).

The values of the scholarships are:

- \$6,200 per annum for bachelor's degree programmes
- \$2,750 per annum for diploma programmes
- 100% tuition fee and \$1,500 per annum for Nitec and Higher-Nitec programmes in ITE

The scholarship will cover the **full remaining duration** of studies for those with <u>at least one year</u> of studies left, subjected to terms and conditions stipulated in the confirmation letter.

# \*The committee may exercise discretion to award eligible students with a one-time off financial assistance in the form of a study award of \$1,200.

### 2) Is there a bond?

By applying, applicants may be contacted by their respective Grassroots Organisations committee on volunteering opportunities.

All recipients of the Scholarship and Study Award will be required to make a pledge during the awards ceremony whereby recipients are **strongly encouraged** to perform community service in the Bishan-Toa Payoh GRC and Marymount SMC grassroots organisations during their vacations and after they graduate.

#### 3) Who is eligible?

The scholarship and study award are open to Singapore Citizen students living in the current Bishan-Toa Payoh GRC and Marymount SMC who have gained admission or are already pursuing local tertiary studies. While there is no restriction in the courses of study, the scholars must pursue courses supported by the Ministry of Education Tuition Grant Scheme in the local universities, polytechnics and ITE. The courses for the local universities are limited to bachelor courses and does not include Masters or Doctorate courses.

The scholarship is open to students studying **full time programmes** at the following local institutes of higher learning:

- 1. All Institutes of Technical Education (ITE)
- 2. Nanyang Polytechnic (NYP)
- 3. Republic Polytechnic (RP)
- 4. Temasek Polytechnic (TP)
- 5. Singapore Polytechnic (SP)
- 6. Ngee Ann Polytechnic (NP)7. LaSalle College of the Arts
- 8. Nanyang Academy of Fine Arts (NAFA)
- 9. National University of Singapore (NUS)
- 10. Nanyang Technological University (NTU)
- 11. Singapore Management University (SMU)
- 12. Singapore University of Technology and Design (SUTD)
- 13. Singapore Institute of Technology (SIT)
- 14. Singapore University of Social Sciences (SUSS)

The applicant must also meet the following criteria:

- Singapore Citizen
- Resident living in the current Bishan-Toa Payoh GRC and Marymount SMC boundary (at time of application for the scholarship)
   (Applicants can visit <a href="https://www.pa.gov.sg/">https://www.pa.gov.sg/</a>, to check 'District information', for current residential address)
- Gross Monthly Per Capita Household Income (PCHI) does not exceed \$2,250.00
- Current year of study OR admissions to be in 2024
- All applicants must apply for MOE Bursary before submitting your application. Please check with your school administrative office on the application process (If awarded scholarship, applicants will have to withdraw their application for MOE Bursary)
- Successful applicants must not have received scholarships and/or bursaries from other schools and private organisations
  (Successful applicants will need to sign a declaration form prior to receiving the Bishan-Toa Payoh GRC and Marymount SMC Community Scholarship)

### 4) Deadline for application

Application form and supporting documents are to be submitted by **28 April 2024.** Applicants waiting for posting results from universities are welcome to apply but are required to provide school's acceptance letter if awarded the scholarship. Applications with incomplete supporting documents will be rejected.

## **5) Application Process**

Applicants may be invited to attend an interview with the selection panel. The selection panel will consider the applicants' examination results, CCA and participation in community service activities. The selection panel may request grassroots leaders to find out more about the applicants and their families' socio-economic circumstances to verify the information in the application forms.

Applicants must separately seek admission to the institutions and must be accepted for admission or have already been admitted before the final selection.

#### 6) Successful Application

The recipient of the Bishan-Toa Payoh GRC and Marymount SMC Community Scholarship needs to submit full examination results to the Constituency Office before each disbursement. Recipient needs to **pass all modules** in **every term** in order to be qualified for the next disbursement (if applicable). The Bishan-Toa Payoh GRC and Marymount SMC Community Scholarship will honour the annual disbursement to successful applicants until end of scholarship term, regardless of changes in electoral boundaries.

Successful applicants would be required to declare if they have received any bursaries or scholarships before the Bishan-Toa Payoh GRC and Marymount SMC Community Scholarship awards ceremony and throughout the awarding period. The scholarship will be revoked if applicant receive any other bursary/scholarship during the awarding period. Recipients may be considered for a one-time off study award should their scholarship be revoked due to receipt of other bursary/scholarship during awarding period.

\*The decision of the selection panel is final. There will be no appeal.
