About the Programme

The Law Society of Singapore and the Competition and Consumer Commission of Singapore ("CCCS") are proud to jointly present the "Competition Primer" and "Consumer Protection Primer" webinars. These webinars will provide an introduction to CCCS's work in the competition and consumer protection fields. Participants will hear from both CCCS officers as well as distinguished legal counsel with a wealth of experience in these areas of law, on the legal frameworks in Singapore and how these frameworks are enforced, as well as glean practical pointers on how to guide their clients.

This is the second of two webinars presented by the CCCS together with the Law Society of Singapore.

This webinar provides an overview of the consumer protection regime in Singapore, unfair trade practices under the Consumer Protection (Fair Trading) Act 2003 ("CPFTA") and how the CCCS administers and enforces the CPFTA. Experienced consumer protection practitioners will share their perspectives on working with the CCCS to file injunction applications against errant suppliers with the courts and advising clients on the CPFTA. The webinar coverage will also include investigations, procedures and legal proceedings under the CPFTA, and recent cases.

Speakers' Profiles



Loke Shiu Meng – Assistant Chief Executive, Legal, Enforcement & Consumer Protection Division, Competition and Consumer Commission of Singapore

Loke Shiu Meng is the Assistant Chief Executive of the Competition and Consumer Commission of Singapore overseeing the Legal, Enforcement and Consumer Protection Divisions. Prior to his current appointment, he served as a Senior State Counsel with the Civil Division of the Attorney-General's Chambers. Shiu Meng brings with him a wealth of experience from his previous appointments in other Organs of State and public sector agencies, such as the Supreme Court, the Ministry of Law and the Ministry of Education, as well as his time as a practicing lawyer in Rajah & Tann LLP.



Rachel Chua –Senior Assistant Director, Consumer Protection Division, Competition and Consumer Commission of Singapore

Rachel is a Senior Assistant Director of the Consumer Protection Division at the Competition and Consumer Commission of Singapore. She is involved in the conduct of investigations under the Consumer Protection (Fair Trading) Act 2003 and the conduct of studies on consumer protection issues in Singapore. Prior to joining CCCS, Rachel was the compliance officer of a licensed fund management company.



Ng Ming Jie – Acting Director, Consumer Protection Division, Competition and Consumer Commission of Singapore

Mr. Ng Ming Jie is the Acting Director of the Consumer Protection Division at the Competition & Consumer Commission of Singapore (CCCS). In his role, Ming Jie supervises the conduct of investigations against errant suppliers who persistently engage in unfair trade practices under the Consumer Protection (Fair Trading) Act 2003. He also supervises the conduct of market studies to better understand and improve the state of competition and consumer protection in different sectors and industries in Singapore. An economist by training, Ming Jie joined CCCS in 2009 after graduating with a Bachelor of Social Science (Honours) from the National University of Singapore (NUS). Prior to joining the Consumer Protection Division in April 2022, Ming Jie was the Deputy Director of the Business & Economics and Policy & Markets Divisions.



Kala Anandaraj – Head, Competition & Antitrust and Trade, Rajah & Tann Singapore LLP

Kala Anandarajah, always a forerunner in niche areas of the law, practices in Competition (merger control, cartels etc), Trade (export controls, FTAs, sanctions etc), and Consumer Protection. She also has strong practices in EHS / ESG and Employment Laws. Kenny's main areas of practice are in litigation, arbitration and dispute resolution (including commercial and general matters). He has advised on and provided services over a wide range of contentious work, including consumer protection matters.

He has been appointed as a Legal Assessor by various statutory boards, and has also acted as prosecution counsel and plaintiff counsel for various government authorities.

Angus Xie – Senior Assistant Director, Consumer Protection Division, Competition and Consumer Commission of Singapore

Mr. Xie Junhao, Angus is a Senior Assistant Director with the Consumer Protection Division of the Competition and Consumer Commission of Singapore (CCCS), leading investigations into complaints concerning the consumer protection provisions of Singapore's Consumer Protection (Fair Trading) Act (CPFTA). Over the past 14 years, he has been involved in the field of enforcement and investigation. Commencing his public service career in 2009 with the Central Narcotics Bureau (CNB), Singapore, he spent 7 years as a Senior Narcotics Officer, and was involved in a wide range of investigations into serious drug trafficking cases which are heard in the High Court of Singapore. During his stint at the CNB, he was attached to the Australian Federal Police (AFP), Sydney office for 3 months, to study AFP's methodology on combating organised crime, narcotics trafficking and to be trained on the conduct of video recorded interviews. In 2016, he joined the team responsible for setting up the first Consumer Protection department in Singapore. He was the team leader for the first and several cases involving injunction proceedings and undertakings given by suppliers who engaged in unfair practices.





Winnie Ching – Senior Director, Legal Division, Competition and Consumer Commission of Singapore

Winnie Ching is the Senior Director (Legal) at the Competition and Consumer Commission of Singapore (CCCS). In her role, she is responsible for reviewing decisions of CCCS, supervising CCCS's competition and consumer protection investigations and projects, and providing advice on legal and policy matters. Winnie has led or supervised complex cartel investigations, abuse of dominance cases, mergers and consumer protection investigations. She currently co-supervises the Mergers Assessment Unit within CCCS.

Prior to joining CCCS, she worked at the UK Office of Fair Trading (now the Competition Markets Authority) as an Assistant Director of Litigation where she led the litigation of a number of key competition and consumer protection cases in the UK courts including to the Competition Appeal Tribunal, UK Court of Appeal and UK Supreme Court. Winnie has also worked as a solicitor in private practice and at the Australian Competition and Consumer Commission as a Principal Investigator of both competition and consumer protection matters.

Winnie has a Masters with distinction from Kings College London in EC Competition Law, a Bachelor of Laws and a Bachelor of Economics from Macquarie University, Sydney.
